

ION ORCHARD TOURIST INITIATIVES 2026

Date: From 1 August 2026

Promotions:

- Promotion 1: First 50 tourists monthly with a minimum same-day spend of \$1,000 at any participating ION+ Rewards stores in ION Orchard will receive 75 ION+ Points (worth \$30 e-vouchers).
- Promotion 2: First 50 tourists monthly with a minimum same-day spend of \$5,000 at any participating ION+ Rewards stores in ION Orchard will receive 375 ION+ Points (worth \$150 e-vouchers).
